As Chairman of SUVCW's National Committee on Promotion and Marketing, I am pleased to share with you that the Committee is launching an initiative to produce short video recordings of Brothers that will be used as a tool for recruiting new Brothers. I am reaching out to you today to ask for your assistance in identifying Brothers in your Departments who would make appropriate candidates for these videos.

Committee members met this week and agreed that, for the purpose of recruitment and especially recruitment of younger Brothers, emphasis will be placed on producing video recordings of Brothers who fall in the 20 to 35-year-old age range. At the same time, the Committee felt strongly that it is equally important to capture the perspective of Brothers who have been members of SUVCW for 50 or more years. I am asking that you identify from within your respective Departments Brothers who meet these criteria and who are willing to be interviewed "on-camera" and comfortable doing so. Ideally, we would like to have no more than five Brothers from each Department who meet the criteria of 20 to 35 years of age and as many of the 50+ SUVCW members as possible.

During the video recordings, which will be conducted in-person where possible and otherwise via online platforms such as Zoom, Brothers will be asked a series of questions by a member of the Committee on Promotion and Marketing. The responses will be video recorded and edited as necessary before the final product is shared by SUVCW on our website, across our social media platforms (Facebook, Instagram, LinkedIn, and Twitter) and ultimately by Departments and Camps in recruitment efforts. The questions that Brothers will be asked will touch on what attracted the Brother to join SUVCW (including for those Brothers who have a Union Army Civil War ancestor questions about the ancestor), what has motivated them to stay involved in SUVCW, etc. The full list of questions will be shared in advance of the interviews.

Once you have identified your list of Brothers, please send me their names, age range (i.e., 20 to 35 or member for 50+ years), email addresses and telephone numbers so that a member of the Committee can reach out to them to schedule the interview. I ask that you provide this information by the 1<sup>st</sup> of August 2020.

Brother Department Commanders, the SUVCW has an unprecedented opportunity to employ modern technology and bring its benefits to bear in the essential business of ensuring the future of our Order. The Promotion and Marketing Committee is counting on you to provide us the voices that we need to make this initiative a success. Thank you in advance for your support.
