I very much hope that this communication finds all Brothers of the Department of the Chesapeake and their families in good health, especially considering the extraordinary circumstances that all of us are experiencing.

I ask for your support and cooperation as I work with the Department Officers and Councilors in the coming days and weeks to identify and address these and other challenges and communicate to you in the near future the solutions that we believe will best serve the needs and interests of the Brothers and Sisters of the Department of the Chesapeake.
